The Regional Tripartite Housing Committee (RTHC) would like to welcome new elected officials and new employees in the community housing sector by providing you with this checklist to help you identify the housing context for the First Nations in Quebec. You will find in this checklist a short description of federal housing programs, a summary of regional needs, the contact information for the main stakeholders, as well as various useful links. # **About the Regional Tripartite Housing Committee (RTHC)**

The RTHC consists of representatives of the Assembly of First Nations Quebec–Labrador (AFNQL), Indigenous Services Canada (ISC) and the Canada Mortgage and Housing Corporation (CMHC). Our mission is to provide recommendations to respective authorities of the 3 partners in order to improve housing conditions for First Nations members. The Committee will give priority to partnership, information sharing, discussions and networking, to ensure the advancement of dossiers of mutual interest.

## **Programs available to First Nations on-reserve**

#### **ISC**

First Nations that receive ISC funding for on-reserve housing can use these funds to meet a wide range of needs: building; renovation; lot servicing; maintenance; insurance; debt servicing; planning and management of the housing portfolio; mould elimination.

The First Nations Market Housing Fund (FNMHF) helps community members obtain loans to purchase, rent or renovate residential properties. # **Community Needs**

The AFNQL maintains on a regular basis the status of housing in First Nations communities in Quebec and Labrador. The most recent data (2014) collected from First Nations clearly illustrate that there is a housing crisis in the communities. Here is a summary of the major needs identified:

9,433 new units required, especially to eliminate overcrowding in the next 5 years

4,983 units need to be renovated or repaired

1,636 units need to be decontaminated (mould)

8,251 lots do not have sufficient infrastructure

The report describes the trends and the challenges that characterize First Nations on-reserve housing. The report also presents the approach which is promoted by the Chiefs to solve the housing crisis.
